

OFFICIAL RULES OF THE HUNT FOR ICONS SWEEPSTAKES

NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE OR PAYMENT OF ANY KIND WILL NOT INCREASE YOUR CHANCES OF WINNING.

Eligibility: The Hunt for Icons sweepstakes (“Promotion”) is open only to natural persons who are legal residents of the States of America, who are at least eighteen (18) years old. Promotion may only be entered from and in eligible jurisdictions. Promotion Entities, prize providers, and their parent, subsidiary and affiliate companies, employees, agents and suppliers, as well as the immediate family (spouse, parents, siblings and children) and household members of each such employee are not eligible to participate. In the event of a dispute as to the identity of an entrant, the authorized account holder of the account will be deemed to be the entrant (“Entrant”). Administrator may request any potential winner to provide proof that such person is the winner. All potential winners are subject to verification before any prize will be awarded. Subject to all applicable federal, state, and local laws and regulations. Void where prohibited. Sponsor: The Sponsor of the Promotion is GMMB Inc. as Agent for its client the Washington Health Benefit Exchange (“Sponsor”).

Administrator: The Administrator of the Promotion is Fancam Ltd. (“Administrator” also known as “Fancam”).

Prize Provider: Live Nation Marketing, Inc. (“Live Nation”).

Sponsor and Administrator are collectively referred to herein as “Promotion Entities”.

Timing: The Promotion period begins at 8:00 AM Pacific Time (“PT”) on January 9, 2017 and ends at 11:59 PM PT on January 31, 2017. Administrator’s clock is the official time keeping device of the Promotion.

Each Entrant will receive one (1) entry into the Promotion after successfully completing and submitting the registration form and finding and clicking on the 5 hidden icons.

For all entries: Each participant is eligible to submit up to three (3) Promotion entries during the Promotion Period, regardless of method or combination of methods of entry or number of entries submitted. Total entries into the Promotion not to exceed three (3) per Entrant. Multiple Entrants are not permitted to share the same email address or other relevant account. Any attempt by any Entrant to obtain more than the stated number of entries by using multiple/different email addresses, identities, registrations and logins, or any other methods will void that Entrant’s entries and that Entrant may be disqualified. Use of any automated technology or system to participate is prohibited and will result in disqualification. Any automated receipt (such as one confirming delivery of

Two (2) Grand Prizes each consisting of two (2) VIP Tickets (“VIP Tickets”), one (1) Premiere campground access pass and a tour of Sasquatch!® Music Festival 2017 at the Gorge Amphitheatre in George, WA scheduled to take place on May 26, 2017 through May 28, 2017. A VIP Ticket includes 3-day reserved passes to the festival, access to VIP viewing areas at four stages and a dance tent, access to the Cliff House, and in and out access to the event for all three days. Selection and Verification of Potential Winners: Administrator will randomly select winner(s) from all eligible entries on or around February 6, 2017. Administrator's decisions as to the administration and operation of the Promotion and the selection of potential winners are final and binding in all matters related to the Promotion. Administrator reserves the right to disqualify any participant or winner and may refuse to award any prize to a person who is ineligible or has violated any rule, gained unfair advantage in participating in the Promotion, or obtained winner status using fraudulent means.

All potential winners are subject to verification by Administrator. Administrator will not accept screen shots or other evidence of winning in lieu of its validation process. Each potential winner will be notified by mail, email or phone. Each potential prize winner may be required to sign and return an Affidavit of Eligibility, Liability and Publicity Release ("Affidavit") (except where prohibited), which must be received by Administrator within seventy-two (72) hours of the date notice or attempted notice is sent, in order to claim a prize (if applicable). If a potential winner of any prize cannot be contacted, fails to sign and return the Affidavit within the required time period (if applicable), declines the prize or prize is returned as undeliverable, such potential winner forfeits the prize. In the event that a potential winner is disqualified for any reason, Administrator will award the corresponding prize to an alternate winner by random drawing from among all remaining eligible entries. All alternate potential winners are subject to all requirements set forth in these Official Rules. Only three (3) alternate winners will be selected, after which the prize will remain un-awarded.

Administrator reserves the right to cancel, suspend and/or modify the Promotion, or any part of it, if any fraud, technical failures or any other factor beyond Promotion Entities' reasonable control impairs the integrity or proper functioning of the Promotion, as determined by Administrator in its sole discretion. In such event, Administrator reserves the right to award the prizes at random from among the eligible entries received up to the time of the impairment.

Administrator reserves the right, in its sole discretion, to disqualify any individual it suspects or finds to be tampering with the entry process or the operation of the Promotion or to be acting in violation of these Official Rules or any other promotion or in an unsportsmanlike or disruptive manner. Any attempt by any person to deliberately undermine the legitimate operation of the Promotion may be a violation of criminal and civil law, and, should such an attempt be made, Promotion Entities reserve the right to seek damages from any such person to the fullest extent permitted by law. Promotion Entities' failure to enforce any term of these Official Rules shall not constitute a waiver of that provision.

Promotion Entities reserve the right to modify prize award procedures. The Promotion and these Official Rules, and the validity, construction, performance, and enforcement thereof, shall be governed by and construed in accordance with the laws of State of California, without giving effect to any choice of law or conflict of law rules (whether of the State of California or any other jurisdiction), which would cause the application of the laws of any jurisdiction other than the State of California.
